## **Summary**

## **Selected Project Experience**

Performed a case study analysis for three cities in each state WI, IN and MI to evaluate how public-private partnerships enhance urban forestry programs. The USFS and other Dept. of Agriculture agencies are able to pass grant money through state DNR programs to improve and enhance programs.

#### **Previous Work Experience**
